

Country Addendum

In connection with the Master Services Agreement – Merchant entered into between **Alipay (Europe) Limited S.A.** (“**Alipay Europe**”) and [**Main signing entity name**] (“**Merchant**”), dated [•] (the “**Master Agreement**”), this Country Addendum is entered into on the date of the last signature on the signature page (the “**Country Addendum Effective Date**”) between Alipay as identified in section (A) below (“**Alipay**”) and the entity as identified in section (B) below (“**Merchant’s local entity name**”) (each a “**Party**” and together the “**Parties**”) in relation to the provision of AMS to [**Merchant’s local entity name**] in the Merchant Location.

This Country Addendum automatically incorporates the terms of the Master Agreement, provided that (i) any reference to “Merchant” in the Master Agreement (as so incorporated herein) will be deemed to refer to [**Merchant’s local entity name**] and (ii) the terms of this Country Addendum shall prevail to the extent of any inconsistency between this Country Addendum and the Master Agreement. This Country Addendum is a separately enforceable agreement from the Master Agreement.

All capitalized terms used but not defined herein shall have the same meaning given to them in the Master Agreement.
